Message from the President

When I sat down to write this message, my last as CVATC's president, I found myself going back and reading all of the newsletter articles I wrote over the past four years. I will probably take a walk in the snow later today, but I started the day off with a stroll down "Memory Lane". It struck me how each of the past four years seemed to have a distinct theme. In 2017. it was the dying ash trees and crazy amount of blowdowns our sawyers had to deal with to keep the Trail open. In 2018, it was the incessant rain and resulting mud. We had work days postponed due to rain and snow. Meetings, emails, and letters regarding our efforts to save the Scott Farm consumed much of 2019. And, of course, 2020 came with a global pandemic that caused the National Park Service to suspend all A.T. volunteer activities for three months, with strict "return to Trail" quidelines afterward.

Looking at the past four years more holistically, thanks to all of you our membership numbers, club donations, and volunteer hours increased significantly. Trailmaster's Report

As we resume our Club's trail work program in March, volunteers must continue to follow the COVID-19 safety procedures developed last year. Each new A.T. volunteer needs to review the COVID-19 protocols that can be found on the Appalachian Trail Conservancy (ATC) website.


To find the safety procedures, go to ATC's homepage and hover over "GET INVOLVED", then under "Volunteer" select "Safety and Training". On that page see "Volunteer Protocols During COVID-19". After reviewing the protocols, volunteers are asked to complete a required online acknowledgement.

In addition to the COVID-19 acknowledgement, each volunteer must complete an Individual Volunteer Service Agreement Form (OF301a) in order to be covered by the Federal Volunteer in Parks (VIP) program for injury and liability protection. Paper copies of the OF301a form are available at club work trip events or can be requested by emailing me at ccdunn11@verizon.net.

If volunteers would like to perform individual, independent trail projects rather than participate in the monthly group trips, please contact me at the previously listed email address or call 717-761-7723 for an assignment.

Finally, as members hike portions of our Club's 17-mile A.T. section during the early spring "mud season" and notice particularly troublesome mud holes and trail damage, please report them to me. Hope to see you on the Trail this year.

CVATC Efforts to Save the Scott Farm



The Scott Farm Trail Work Center, located along the A.T. in Middlesex Township, has provided extremely important support to the local Trail community for nearly 30 years. The farm structures had served, until recently, as the base for ATC's Mid-Atlantic fall trail crew and as a training center for sawyer certification and summer Ridge Runners patrolling the Trail. The workshop, garage, and storage shed have also been a very important resource for CVATC for the past several decades. Our club continues to store trail tools, mowers, and supplies at the farm, and most of our monthly group work trips meet there. The Scott Farm house and barn are over 100 years old and are on the Cumberland County Historical Society's watch list of historic properties.

Two years ago, at the spring Mid-Atlantic Regional A.T. Partnership Committee meeting, CVATC representatives met with a National Park Service A.T. staff person and discussed NPS plans to demolish the Scott Farm facilities and restore the site to a natural appearance. NPS has tens of thousands of structures nationwide and is

seeking to reduce its operating costs and liabilities by eliminating what it regards as non-essential structures. The Scott Farm, along with some other NPS-owned structures, has experienced substantial deferred maintenance for many years. However, for CVATC and the Mountain Club of Maryland, our A.T. maintaining neighbor to the north and south of our 17-

mile valley section, the Scott Farm has been and continues to be very functional and extremely useful.

CVATC members immediately began exploring ways to preserve the Scott Farm facilities. We learned that NPS is not permitted to sell surplus properties but can exchange them for desirable properties of like value and public benefit. Our club soon discovered that the Central Pennsylvania Conservancy (CPC) was in the process of negotiating the acquisition of land and residual easement interests in property relevant to the A.T. on Peters Mountain in Dauphin County. This fortuitous opportunity led to a joint understanding between CPC, CVATC, and NPS to acquire and exchange a portion of the Peters Mountain property for the Scott Farm.



After a successful fundraising campaign, CPC settled on the mountain property in August of last year. Currently, a survey of the tract surrounding the Scott Farm buildings, which CVATC leaders defined for the exchange, is nearing completion. The next steps are to seek subdivision approval from Middlesex Township, deed preparation, define use and ownership agreements between CPC and several Trail and environmental groups, and finally, complete internal NPS procedures.



With steady progress, we hope to complete the exchange by the end of this year. In the meantime, NPS has continued to allow CVATC and other A.T. maintaining organizations to continue using the workshop and storage facilities. CVATC has assumed the lead role in overseeing the property and paying bills for electric service and fuel oil to minimally heat the house during the winter. Additional club volunteers to help maintain and patrol the grounds plus contributions to help pay the utility bills are needed. Vicky Kelley is the chair of the club's Scott Farm committee.

We look forward to preserving the Scott Farm for many more years of service to the Trail and the local conservation community and invite your participation. Stay tuned as our work to save the Scott Farm progresses.
